- A committee to discuss the residency requirement will meet to review the issues and options will be comprised of Trustee McClain, Trustee Reeves, Chief Farhat and Local 4732 representatives.
- c. Deputy Fire Chief Position Update
 - Chief Farhat updated the Board on his concerns with the ESCI deputy chief recruitment process to date. The gentleman that was handling the recruitment has been relieved of our project. Lane Wintermute and the former CEO (current senior advisor) of ESCI will be restarting the recruitment process.
 - Chief Farhat would like to give ESCI the opportunity to correct the issues and complete the process. If ESCI is not able to follow through; he will research other recruitment companies.
 - Chief Farhat stated that he has thought about hiring a sub-contractor to assist with some of the projects until a deputy fire chief is hired and will talk to the Big Sky Resort Tax Board to inform them of the situation and discuss funding of the position.
- d. ESCI Master Plan Update
 - Chief Farhat has reviewed the master plan draft and has been in communication with ESCI. ESCI may be available to present the final document at the November meeting if it is completed.
- e. Briefing by David Fowler, Architect, on Station #1 Renovation
 - Chief Farhat stated that the project is at the point of deciding if funding should be approved for a renovation of Station #1. Chief Farhat suggested forming a committee to analyze how to proceed with the renovation.
 - Trustee Johnson proposed looking at options for a new station.
 - Trustee McClain appointed a committee to discuss the topic and appointed Trustee Collins, Trustee Johnson, Chief Farhat and David Fowler.
