#### PROJECT BACKGROUND AND DESCRIPTION

The Big Sky Fire District (aka Big Sky Fire Department or BSFD), a Montana Rural Fire District, is seeking qualified independent licensed auditors by the State of Montana (Auditor) to perform an annual audit of the District's financial operations for Fiscal Year 2016-2017, with an opportunity for performing annual audits for FY 2017-2018 and 2018-2019 upon the successful completion of the FY 2016-2017 audit.

BSFD is seeking an Auditor with sufficient governmental and auditing experience, as measured by past project history. This Request for Proposal (RFP) is for submission of a proposal for an audit that shall be performed in accordance with attestation standards established by the American Institute of Certified Public Accountants and as required by the applicable Montana Codes Annotated, the Administrative Rules of Montana and Federal regulations.

This RFP shall not commit the BSFD to enter into any agreement to pay any expenses incurred in preparation of any response to this request, or to procure or contract for any supplies, goods or services. The BSFD reserves the right to accept or reject any and all responses to this RFP.

This RFP is governed by the laws of the State of Montana and venue for all legal proceedings shall be the Eighteenth Judicial District, Gallatin County. By offering to perform services under this Procurement, all Offerors agree to be bound by the laws of the State of Montana and the local authority having jurisdiction.

## **Annual Audit Services Evaluation Criteria**

#### 1. HISTORY AND EXPERIENCE WITH SIMILAR PROJECTS (50 points):

• Describe firm's history, size, complexity and relevance to this project. Emphasis to be placed on firms that have experience with rural fire district auditing experience.

# 2. TOTAL COST FOR PROPOSAL (50 points):

 The costs quoted for this project shall include all costs needed to complete this project.
